4. First-aid measures

Inhalation

Remove victim to fresh air and keep at rest in a position comfortable for breathing. Provide oxygen or artificial respiration if needed, preferably mouth to mouth if possible. Do not use mouth-to-mouth method if victim inhaled the substance. Induce artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. Get medical attention if symptoms occur.

Skin contact

Take off contaminated clothing and wash before reuse. Rinse with water. Get medical attention if irritation develops and persists.

Eye contact

Rinse with water about 15-20 minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Get medical attention if irritation develops and persists.

Ingestion

Rinse mouth. Do not induce vomiting without advice from poison control center. Never give anything by mouth to a victim who is unconscious or is having convulsions. Get medical attention if symptoms occur.

5. Fire-fighting measures
